



MEMORANDUM OF UNDERSTANDING BETWEEN UNIVERSITAS MUHAMMADIYA KALIMANTAN TIMUR (UMKT), THE REPUBLIC OF INDONESIA AND ISLAMIC UNIVERSITY OF TECHNOLOGY, BANGLADESH

This Memorandum of Understanding (hereafter referred to as the "MoU") is made on this 10 day of July 2023

between

Universitas Muhammadiyah Kalimantan Timur, a Private University of higher education learning established in 2017 as part of the Muhammadiyah social organization and has its address at Jl. Ir. H. Juanda No. 15, Samarinda, East Kalimatan, Indonesia. (Hereinafter referred to as "UMKT").

and

Islamic University of Technology, an International University established by the 57-nation organisation, Organisation of Islamic Cooperation (OIC), to develop human resources of its member states in the fields of engineering, technology, and business as well as technical and vocational education with a vision to be a leading university in the world. Islamic University of Technology (IUT) is located at Board Bazar, Gazipur 1704, Bangladesh (hereinafter referred to as "IUT").,

Both parties are collectively referred to hereinafter as the "Parties" and individually as the "Party".

PREAMBLE:

The parties agree

- 1. To enter into an agreement for academic cooperation.
- 2. That the academic cooperation will promote further educational collaboration and cultural understanding and agree to further continue their common interest in promoting mutual cooperation in the area of education and research; and
- 3. To implement the MOU under the terms and conditions hereinafter set forth.

NOW, THEREFORE, for and in consideration of their promises and undertakings, the Parties agree as follows:

ARTICLE 1 PURPOSE AND OBJECTIVE

- (1) The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations, and national policies from time to time in force in each country, agree to strengthen, facilitate, promote, and develop co-operation between the Parties and their respective stakeholders with an emphasis to cooperate in Academic programs and Research between the Parties for mutual benefits.
- (2) During the term of this Memorandum of Understanding, any cooperation between the Parties will be formalized and secured by a written agreement detailing the rights and responsibilities of the Parties, including any financial commitments, and such cooperation shall commence and be implemented only after the written agreement is executed by the duly authorized representatives of Parties.

ARTICLE 2 AREAS OF COOPERATION

Each Party will, subject to the laws, rules, regulations, and national policies governing the subject matter in their respective countries, endeavor to take necessary steps to manage and facilitate such cooperation.

The broad forms of cooperation identified by the Parties are:

- a. Research and Educational activities such as joint research educational development in the form of training or research activities or both.
- b. Exchange of invitations to scholars of both institutions (Research personnel, and Graduate students) visits and sharing of experiences.
- c. Exchange of Invitations to scholars for participation in conferences, symposia, and Seminars.
- d. Exchange of information in fields of interest to both parties.
- e. Other forms of cooperation relating to humanity services/activities are to be mutually agreed upon by the Parties.

ARTICLE 3 CONTRIBUTION BY PARTIES

In accordance with the prevailing laws and regulations in Indonesia and Bangladesh, and subject to personnel and budget limitations, the Parties shall assign qualified experts and faculty members to assist in the implementation of activities under this MOU.

ARTICLE 4 AMENDMENTS, EFFECTIVE DATE, DURATION, AND TERMINATION

- (1) Either Participant may request in writing a revision, modification, or amendment of all or any part of this Memorandum of Understanding.
- (2) Any revision, modification, or amendment agreed to by the Parties will be reduced into writing and will form part of this Memorandum of Understanding.
- (3) Such revision, modification, or amendment will enter into force on such date as determined by the Parties.
- (4) Any revision, modification, or amendment will not prejudice the rights and obligations arising from, or based on, this Memorandum of Understanding before or up to the date of such revision, modification, or amendment.
- (5) Amendment to this Memorandum of Understanding can only be made after mutual consent is achieved by the consultation and confirmation in writing by the Parties given at least 6 (six) months in advance. Such amendments will form an integral part of this Memorandum of Understanding and will enter into force on such date as may be determined by the Parties.
- (6) This Memorandum of Understanding will enter into force on the date of its signing and will remain in force for a period of five (5) years. Thereafter, it may be extended for a further period of five (5) years subject to the mutual agreement of the Parties.

ARTICLE 5 DISPUTE SETTLEMENT

Both Parties shall first attempt to resolve any dispute arising out of or relating to this MOU through discussion and negotiation between the Parties acting in good faith.

ARTICLE 6 NOTICES

Any notice or request given or made by one Party to the other under this MOU shall be in writing in the language of English and shall be addressed to the appropriate office as is designated in writing hereinafter:
